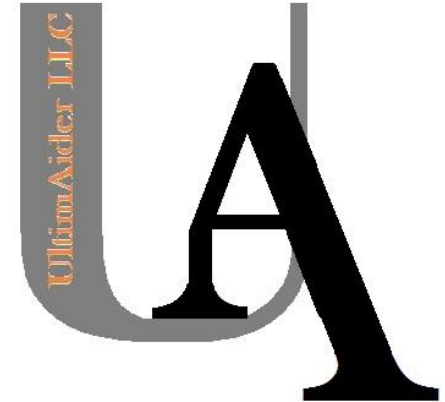

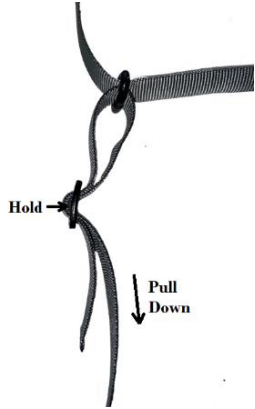

## How to tips

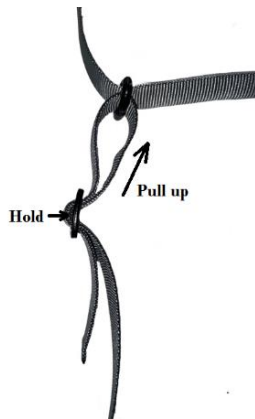
### Increase distance between steps

Hold tri-glide with one hand while pulling down on the back strap below the tri-glide. Adjust the tri-glide to the desired position. Always leave a minimum of 2 inches of excess strap hanging after the tri-glide.



### Decrease distance between steps

Hold tri-glide with one hand while pulling up on the back strap above the tri-glide. Adjust tri-glide to the desired position. Always leave a minimum of 2 inches of excess strap hanging after the tri-glide.



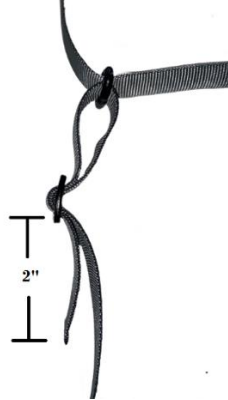
### Removing a step

Remove excess strapping from tri-glide then pull strap out of the steps connecting link. Repeat on both sides.



### Add step to existing set up

Remove the bottom step of your existing UlтимAider. Then completely remove each tri-glide off that step and set aside. Now slide the step connecting links that came preinstalled on your new step over each side of the step you removed. Finally reinstall the step previously removed back by following the remove step instructions in reverse. Always leave 2 inches of excess strap after the tri-glide.



### Convert a Step to a Swaider

Remove all hardware from the step. Use an arrow (without a tip) to push the step insert out. Reinstall each tri-glide creating a loop on each side.
